Between January 19 and February 16, 2011, EAN members will elect **one(1) ESP director for a two-year term; three (3) at-large directors for a two-year term and three (3) at-large directors for a one-year term.** On the reverse of this memo is an official petition for any member who might wish to be placed on the ballot as a candidate.

**All members (including ESP) are eligible to run and to sign petitions for any EAN office.**

Those elected assume office on June 15, 2012. (EAN Bylaws Article IX provides additional information.)

To be a candidate for a board of directors seat, you will need the signatures of **50 members that are from at least 3 schools.** This will place your name on the ballot.

**Candidates are responsible for delivering or faxing their petitions to the EAN office.**

Each candidate must provide résumé information. (*Only one complete résumé form need be submitted with petitions.*)
